Explore space with Prof. Robert Pepin, speaker for Annual Banquet, May 16

On reviewing the speakers' topics for this past year's luncheon meetings, I was struck by the contemporary nature of the subjects and the uniformly high quality of the presentations. In every instance, in the time available, we heard about the current status in a particular discipline or activity as well as the promise and problems.

As might be expected, controversy was often present. The topic for May and the annual banquet meeting is markedly different. The field of research is current but the focus is on material far removed in time and space.

In late January, my attention was drawn to an item in *eNews for Alumni and Friends*: "The University's Bob Pepin has always been fascinated by ideas about how our solar system formed. Since NASA's Stardust mission returned its first samples of material from a comet and interstellar dust, January 15, the physics professor has been eagerly awaiting a chance to unearth some of the secrets these particles have carried for billions of years."



I thought, here is a splendid opportunity to view our world from a perspective free of politics, the culture wars, or local issues, such as having to decide how many stadia should be built.

Professor Pepin began his study in the space sciences at UC Berkeley, after a brief affair with oceanography, completing a Ph.D. in 1964. He came to Minnesota just as the Apollo missions to the moon were opening a new research frontier. The scientific "finds" of the lunar samples and a fascination with space exploration drew him into the Apollo program, first as a member of the teams that planned lunar surface activities and the distribution of moon rocks to the science community, and later as science adviser in Mission Control at the NASA Johnson Space Center during the last four Apollo missions.

Pepin returned to Minnesota in the late '70s, a time when space exploration leaped from the moon to Venus, Mars, Jupiter, and beyond. His research at Minnesota helped establish that some meteorites were actually fragments of the Martian surface torn loose and ejected into space by energetic impacts.

His current research focuses on the theoretical aspects of the origin and early history of atmospheres on Earth, Mars, and Venus, and experimentally on analysis of samples collected by two robotic spacecraft missions: "Stardust" gathered dust from a comet; "Genesis" sampled the sun's corona that streams out past the planets as solar wind.
