In addition to serving on the Executive Committee and filling in for the President as needed, the Past President's primary responsibility is to chair the nominating committee. This file contains key communications and documents related to that activity in 2020.

Chairing the nominating committee entails the following:

- Working with the Board of Directors to identify and select nominating committee members (January-February);
- Setting agendas for and presiding over nominating committee meetings (February-April);
- Working with nominating committee members to identify and recruit nominees for the various positions. Each year positions to be filled include President-Elect, Treasurer, Secretary, and at least three new or renewing board members (March-April);
- Bringing a slate of candidates to the Board for review and approval in April;

- Coordinating the election process in conjunction with the current President (May-June).

The nominating committee consists of these three volunteers, and two Board members (the immediate Past-President, who chairs the committee, and one additional Board member). To

identify and put forward a strong pool of candidates, we are seeking a diverse committee with an extensive collective familiarity with the membership. This activity does not involve a significant time commitment—likely two or three meetings with additional email and telephone exchanges.

Member involvement is essential to UMRA's success, particularly in determining leadership for the organization. Please let me know if you are interested in helping in this way or if you would like additional information on the work of the Board.
