



# **Core Mission Support**

- \$45 million incremental each year of the biennium
- Proposed at 50% of projected \$90 million annual cost increases (inflation at 6%)
- The University will cover the remaining 50% with tuition revenue growth, leveraging other revenue growth where possible, and spending cuts
  - Compensation increases to retain faculty and staff including costs of negotiated bargaining agreements
  - Facility costs: utilities, debt, operations
  - Other operating pressures: student support services, mental health support, lab supplies, equipment, library materials, security, technology



#### Minnesota Resident Scholarship

- Recruit MN students to stay in Minnesota at one of our campuses & retain them through to graduation (benefitting 13,000-15,000 students per yr)
- Multi year awards to students at UMC, UMD, UMM and UMR
  - ~\$10,000 over four-year time frame to each MN resident entering as freshmen
- Multi year awards to student at UMTC
  - ~\$5,000-\$7,000 over two or four-year time frame to each MN resident firstgeneration student entering as freshmen or transfer students

#### **Public Safety**

 Supplement ongoing University investments to immediately improve safety and security on all campuses: Installation, ongoing maintenance, replacement and operation of improved building access systems on all campuses; Increased security presence on all campuses based on priority needs by location

# **Additional Items**

<u>American Indian Scholars Program</u>: Provide full tuition and fee scholarships for eligible American Indian students to complete an undergraduate education at any of the University's five campuses (Governor's recommendation).

**Enrollment Driven Tuition Shortfall**: Offset recently forecasted tuition revenue shortfalls across most colleges and campuses of the University of Minnesota system, driven by a variety of factors exacerbated by the COVID-19 pandemic.

<u>**Resident Undergraduate Tuition Freeze</u>**: Hold tuition flat for all resident undergraduate students across all five University campuses for both years of the biennium.</u>

## MPACT Health State Investment Request

- \$300 million to acquire from Fairview the assets and facilities that support the University's academic medical mission
- \$650 million for post-acquisition financial support to operate the facilities, including working capital and covering operating losses
- Total request = \$950 million



# Chemistry Undergraduate Teaching Laboratories



#### **Chemistry Undergraduate Teaching Laboratories** \$92.6 million in state funding

Renovate 95-year-old Fraser Hall to create a 117,000-squarefoot modern chemistry teaching laboratory serving students from every college on the Twin Cities campus. This building will provide 18 active learning laboratories-serving high demand STEM courses-with space for lab preparation, academic support, and collaborative learning. Funding for design was provided in the 2020 bonding bill.



# Agricultural Research & Education Complex (FAARM)



#### Agricultural Research and Education Complex \$60 million in state funding

Design, acquire land, and build a new agricultural research and education complex dedicated to the Future of Advanced Agriculture Research in Minnesota (FAARM). This integrated hub will support researchers, instructors, and industry partners to study all aspects of agriculture, including smart farming, livestock, soil health, water quality, climate, and the sustainability of rural economies.



# Duluth Academic Health Sciences (Design)



#### **\$12 million in state funding**

Design an approximately 180,000 square foot facility in the Duluth Medical District to provide high demand health care education and interprofessional training. The facility's teaching, clinical practice, and research spaces will support Greater Minnesota workforce needs in partnership with area colleges and health systems and serve local communities with a focus on increasing access to health care.



# Crookston Heating Plant & Utility Infrastructure



#### Heating Plant and Utility Infrastructure \$3.3 million in state funding

Replace deteriorated equipment inside the Crookston campus' heating plant, as well as related utility infrastructure to improve safety within the plant and reliability of heat and hot water across campus. The heating plant, built in 1911, provides heat to the entire campus and hot water to most of the academic buildings. The hot water storage tank is degrading and the electrical gear is obsolete.



# Morris Multi-Ethnic Resource Center Improvements



#### Multi-Ethnic Resource Center \$3.3 million in state funding

Improve accessibility and upgrade life safety and building systems in the Multi-Ethnic Resource Center on the Morris campus. Constructed in 1899, this hub for Equity, Diversity and Intercultural Programs is the only campus building original to the Native American boarding school. The building lacks an elevator.
