


George Earl Swift (1848-1936)

Prisoner Exchange / Parole

Prisoner Exchange / Parole

- Lacking means for dealing with large numbers of captured troops early in the American Civil War, the Union and Confederate governments both relied on the traditional European system of <u>parole</u> and exchange of prisoners.
- A prisoner who was on <u>parole</u> promised not to fight again until his name was "exchanged" for a similar man on the other side. Then both of them could rejoin their units. While awaiting exchange, prisoners were briefly confined to permanent camps.
- The exchange system broke down in mid-1863 when the Confederacy refused to treat captured black prisoners as equal to white prisoners.










High Bridge over the Appomattox River




